- 2 FOR A COMPANY THAT WISHES TO OPEN AN ACCOUNT, THE BERMUDA PAINT COMPANY LTD MAY REQUIRE A BANK CREDIT REFERENCE BASED ON THE AMOUNT OF CREDIT REEQUIRED
- 3 BERMUDA PAINT COMPANY LTD WILL SET A CREDIT LIMIT WHICH MAYB NOT BE EXCEEDED WITHOUT THE CONSENT OF THE COMPANY
